# Investing in REDD-plus

Launched October 1<sup>st</sup>, 2009 during UNFCCC Climate Change talks in Bangkok:

Twenty-six recommendations and an executive summary & matrix

- 100 Stakeholders
- Agreed recommendations
- Fed into IWG-IFR and UNFCCC processes



# **Key Messages**

- Broad elements of REDD-plus should include: reducing emission from deforestation and degradation; conservation; SFM; enhancement of carbon stock
- Base REDD-plus firmly on sustainability principles: ecological integrity; social integrity; atmospheric integrity; economic integrity
- REDD-plus finance mechanism must be: effective; efficient; equitable
- Financial stability for REDD-plus can only be achieved through a portfolio approach with a combination of public and private funding and with country's commitments
- The implementation of REDD-plus requires forest-governance reforms through inclusive processes that build on existing forest-governance systems.



# The REDD Readiness Dialogues (2009-Present)

"There will only be limited opportunities to get REDD-plus right. As interest in it grows, so too do the pitfalls of getting REDD-plus wrong... Local peoples are being urged to become involved in REDD-plus at all levels, but are they ready to do so? Are we—the international community ready?"

# Initiative Objectives

- Build a "community of practice" among a group of locally-rooted well-connected REDD protagonists that can continue to engage and make progress on the practicalities of in-country implementation of REDD initiatives;





# Initiative Objectives

Provide well-targeted recommendations to overcome challenges experienced in the REDD readiness phase at the local, national and international levels, the way these levels are linked (for example linking UNFCCC processes, UN-REDD, FCPF, FIP, IWG-IFR and other multilateral and bilateral funds with national and local independent projects<sup>1</sup>
