- ➔ Build a community of practice among a group of locally-rooted well-connected REDD+ protagonists that can continue to engage and make progress on the practicalities of in-country implementation of REDD+ initiatives;
- ➔ Raise awareness and promote exploration of REDD Readiness challenges among a wide spectrum of local stakeholders in Cambodia;
- ➔ Provide well-targeted recommendations to overcome challenges experienced in the REDD Readiness phase at local, national and international levels including the UNFCCC processes;

- ➔ Establish a feedback loop between international and local REDD+ related processes (for example link UN-REDD, FCPF, FPIC, IWG-IFR and other multilateral and bilateral funds with national independent projects) on key REDD Readiness issues.
